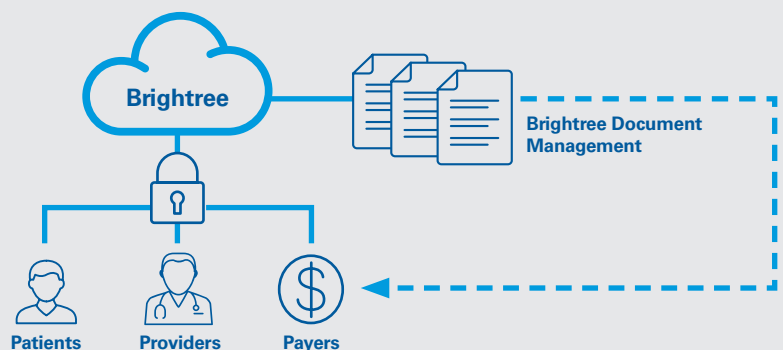

# Brightree document management features

## Get audit-ready, avoid recoupment

- Automatically recognize presence of documents and trigger tasks based on those documents
- Deliver products and submit claims with confidence that documentation is captured

- Ensure the right documents are in place and have been properly reviewed prior to confirmation

## One-click document capture

- Capture and associate documents on the fly from the relevant Brightree screen
- Eliminate the extra steps of browsing and attaching

## Automatic batch document filing

- Automatically associate scanned or electronically delivered Brightree-barcode documents (such as CMNs and delivery tickets) with a specific patient, sales order or item for direct access during the billing review process

## Customized document types

- Define company-specific document types and assign rules that support your specific processes

## Document exception work list

- Automatically receive an exception queue of scanned documents without barcodes or partially captured documents for assignment to records or workflows

## Direct access to electronic documents

## Easy-sort workflow

- Electronically manipulate documents by changing the page order; separate and sort pages into multiple documents; remove individual pages from documents; and/or file directly into the patient's record

## Electronic fax integration

- Consolidate multiple documents into a single fax to respond to audits and appeals faster, while also maintaining proper audit history

## Unified administrative worklist

- Consolidated workflow enables scanning personnel to monitor unfiled documents and transfer management and ownership of aging document batches to better leverage review and indexing resources
